**REQUIRED PROVISIONS:**

1. Name the City of Dallas and its officers, employees and elected representatives as additional insureds, (as the interests of each insured may appear) as to all applicable coverage;
2. Provide for ninety **(90)** days notice to City for cancellation, non-renewal, or material change;
3. Provide for an endorsement that the "other insurance" clause shall not apply to the City of Dallas where City is an additional insured shown on the policy;
4. Permittee agrees to waive subrogation against the City of Dallas, its officers and employees for injuries, including death, property damage, or any other loss;
